

Southland Sharks Ball Carrier Prize Draw Terms and Conditions

1. The Promoter of the Competition is Southland Building Society (“SBS Bank”). The Competition is in no way sponsored, endorsed or administered by, or associated with Facebook. You completely release Facebook from any and all liability associated with this Competition.
2. SBS Bank is offering the chance to win one of seven (7) ball carrier prizes (the “Prize”)
3. Each Prize is for a winning entrant (the “Winner”) to:
 - a. be an official ball carrier at one of the Southland Sharks Invercargill home games in the 2019 National Basketball League;
 - b. receive two General Admission tickets (for the Winner and one Parent or Legal Guardian) to attend the game that the Winner will be the official ball carrier;
 - c. receive an official ball carrier top to be worn at the game that the Winner will be the official ball carrier (and to keep!); and
 - d. receive an SBS Bank prize pack.
4. The competition will run from Friday 5 April at 10:00am to 5pm on Wednesday 10 April 2019.
5. To enter this competition:
 - a. entrants need to be aged between 5 and 13 (evidence of age may be required);
 - b. entrants need to be New Zealand residents
