



SBS Bank 2024/2025 New Zealand Open Pro-Am Prize Terms and Conditions (the "Terms and Conditions")

1. Southland Building Society is a registered bank and operates under the brand SBS Bank (referred to as "**SBS Bank**", "**we**" or "**us**"). SBS Bank together with its subsidiaries are referred to as the "**SBS Group**".
2. SBS Bank is offering the chance to win a 2025 New Zealand Open Pro-Am Entry prize package (the "**Promotion**" and the "**Prize**"). The details of the Prize are set out in Schedule 1 of these Terms and Conditions.
3. The Promotion will run from 9:00 am Saturday, 16 November 2024 to 11:59pm Friday, 6 December 2024 ("**Promotion Period**").
4. To enter the Promotion and be in the draw to win the Prize, you must during the Promotion Period:
 - a. Have opened an SBS Bank NZ Open Special Term Investment Account (which can be found on SBS Bank's website) and have deposited funds ("**NZ Open Special Term Investment**"); and
 - b. Be a New Zealand resident, currently living in New Zealand.
5. Each NZ Open Special Term Investment that is taken out by an individual, individuals jointly or an entity (**Account Holder**) qualifies you for one entry into the Promotion draw. For the absence of doubt, multiple NZ Open Special Term Investments opened under the same Account Holder will only qualify for a single entry into the Promotion draw.
6. Each Account Holder with a NZ Open Special Term Investment fund of \$100,000 or more will also receive one bonus entry into the Promotion draw (limited to one per Account Holder).
7. The Prizewinner (the **Prizewinner**) will be drawn by random selection on Wednesday, 11 December 2024. The first valid entry randomly drawn will win the Prize.
8. To be eligible to claim the Prize, the Prizewinner must:
 - a. Meet the following player requirements for the New Zealand Open Pro-Am tournament:
 - i. Be an active and paid-up Golf New Zealand member,
 - ii. Have a current handicap below 20, with the proviso that the maximum tournament handicap is 18; and
 - iii. Be 18 years or over; or
 - b. Transfer the Prize to a New Zealand resident (currently living in New Zealand) that meets the player requirements for the New Zealand Open Pro-Am tournament above (the **Transferee**), subject to the prior written consent of SBS Bank and Millbrook Tournaments Limited. Note that there are certain restrictions on transfer set out in Schedule 1.
9. The Promotion is not open to:
 - a. the employees of SBS Bank and their families,
 - b. the New Zealand Open organisers and their families; or
 - c. the employees of Millbrook Tournaments Limited, its subsidiaries, agents and/or affiliates and their families.
10. The Prize is not exchangeable or redeemable for cash.

11. The Prizewinner and their Transferee (if applicable) will be announced within seven days (timing at the discretion of SBS Bank), following their confirmation of acceptance of the Prize and that they meet the eligibility requirements to claim the Prize.
12. The Prizewinner will be contacted by telephone and/or email using the contact details provided when taking out the SBS NZ Open Special Term Investment. SBS Bank will advise the Prizewinner of the process required to claim the Prize. If the Prizewinner cannot be contacted or does not claim the Prize (for whatever reason) within 48 hours following the Prize draw, the Prizewinner will forfeit the Prize (and no compensation will be payable) and SBS Bank shall be entitled to undertake a redraw for the Prize in accordance with these Terms and Conditions.
13. The Prizewinner and their Transferee (if applicable) will have 48 hours to confirm the following:
 - a. acceptance of the Prize,
 - b. they meet the eligibility requirements to claim the Prize,
 - c. they agree to these Terms and Conditions to the extent that they have not already agreed to these Terms and Conditions; and
 - d. they agree to adhere to all of the relevant third-party terms and conditions relating to the Prize including the official New Zealand Open conditions of entry, which can be viewed at <https://nzopen.com/amateurs/>.
14. In the event the Prizewinner chooses not to accept the Prize, that Prizewinner will forfeit any rights or claims to the Prize (and no compensation will be payable) and SBS Bank shall be entitled to undertake a redraw for the Prize in accordance with these Terms and Conditions.
15. The Prizewinner and/or the Transferee may be required to sign a declaration confirming their eligibility to accept the Prize (which may include evidence of a valid and current registered golf handicap of below 20 and their valid New Zealand golf identification number). SBS Bank reserves the right to request that the Prizewinner and/or their Transferee provide proof of identity and age (in form and substance satisfactory to SBS Bank) when claiming the Prize.
16. The Prizewinner and the Transferee authorises SBS Bank to use their name and photograph for publicity purposes in all media by SBS Bank, without remuneration. The Prizewinner and the Transferee agree to make themselves available to SBS Bank for this purpose.
17. If the Prize or part of the Prize becomes unavailable due to unforeseen circumstances, SBS Bank is not liable to the Prizewinner or the Transferee for a replacement or substitute prize or to pay any compensation as a result.
18. SBS Bank reserves the right to refuse awarding the Prize to any entrant who SBS Bank determines (acting in its sole discretion) to have:
 - a. breached any aspect of these Terms and Conditions,
 - b. breached any relevant third-party terms and conditions relating to the Prize,
 - c. tampered with or falsified any aspect of their entry to the Promotion or the process to the claiming of the Prize
 - d. gained unfair advantage in participating in the Promotion; or
 - e. became a Prizewinner using fraudulent or dishonest means.
19. SBS Bank reserves the right, at any time, to verify the validity and eligibility of any entrants to the Promotion and shall be entitled to disqualify any entrants from the Promotion that SBS Bank believes (acting in its sole discretion) to have failed such verification checks or to have otherwise breached these Terms and Conditions.

20. Unless explicitly stated in these Terms and Conditions, the Prizewinner and/or their Transferee will be responsible for their own expenses including, but not limited to, travel/flights to the event, spending money, meals, drinks, local transport, laundry charges, activities, incidentals, gratuities, room charge-backs, services charges, travel insurance and all other ancillary costs associated with claiming the Prize.

General terms

21. SBS Bank's decision or determination in relation to any aspect of the Promotion and these Terms and Conditions is final and no correspondence or deliberation will be entered into with any entrants.
22. SBS Bank reserves the right to extend, postpone or cancel the Promotion and to modify these Terms and Conditions without notice.

To the extent permitted by law, SBS Bank and any other person or party associated with this Promotion shall not be liable to the Prizewinner and/or the Transferee in respect of any loss, damage or injury whatsoever (including, but not limited to, any direct, indirect, and/or consequential loss or damage), including personal injury suffered as a result of, or arising in connection with, the Promotion or winning (or not winning) the Prize.

SCHEDULE 1

Details of the Prize

The 2024/2025 New Zealand Open Pro-Am Prize package includes the following:

Part 1 – Player Experience:

- An Amateur entry to the New Zealand Open Pro-Am Championship which runs over four (4) days from 27 February 2025 to 2 March 2025 (**Tournament Week**) and playing alongside a professional golfer, which includes:
 - Exclusive tournament event invitations to the:
 - Official Tournament Welcome,
 - Partners Lunch; and
 - Official Tournament Gathering,
 - VIP Hosting: Passes for the Prizewinner and a guest to enjoy the corporate hospitality each day of the Tournament Week
 - Transfers, merchandise, and hosting;
 - Practice range facilities at Millbrook Resort,
 - Practice rounds during the first three days of the Tournament Week,
- Entry is into the Pro-Am on Thursday, 27 February and Friday, 28 February 2025, before the two-round cut of 40 Pro-Am teams. Those who do not make the first cut will be invited to play in a separate Pro-Am at The Hills on Saturday, 1 March 2025.

Part 2 – Accommodation

- Six-nights' accommodation and breakfast at Millbrook Resort during the 2024/2025 New Zealand Open Pro-AM for the Prizewinner and a guest

Prize Transfer

The Prizewinner may choose to:

- a) transfer *Part 1 – Player Experience* and *Part 2 – Accommodation* in their entirety to the Transferee; or
- b) transfer *Part 1 – Player Experience* to the Transferee and retain *Part 2 – Accommodation* for themselves.

In the absence of doubt, the Prizewinner is not able to receive *Part 2 – Accommodation* without either accepting or transferring *Part 1 – Player Experience*.
