

SBS Lite Charity Promotion - Terms and Conditions



*Southland Building Society is a registered bank and operates under the brand "SBS Bank" (referred to as **SBS Bank, we or us**). SBS Bank together with its subsidiaries is the **SBS Group**.*

SBS Lite Charity Promotion

Simply become a new customer of SBS Bank by opening a SBS Lite Account and the Highlanders will receive \$50.00 for every new account opened to support their official charity partner, The Stonelake Foundation. You will also go into the draw to win 1 of 3 Highlanders Prize Packs (the **Promotion**). The Promotion commences at 9:00am on 22 February 2021 and closes at 11.59pm on 31 March 2021 (the **Promotional Period**). Entry into the Promotion is deemed as acceptance of these terms and conditions.

Entry

- 1) To enter into the Promotion, you must:
 - i) be a New Zealand resident aged 18 years or over;
 - ii) not be an existing customer of SBS Bank; and
 - iii) successfully open a transactional SBS Lite Account during the Promotional Period via the Highlanders "SBS Lite Charity" promotion page located at: www.sbsbank.co.nz/support-the-highlanders.
- 2) SBS Lite Accounts opened for savings or investment purposes will not be eligible for the Promotion.

Promotion Terms

- 3) Employees of the SBS Group and their immediate families are not eligible to enter the Promotion.
- 4) The Promotion is available for the Promotional Period only and may be withdrawn, amended or extended at any time by us at our discretion. We reserve the right, in our sole discretion, to determine whether any person has met the entry criteria for the Promotion set out in paragraph 1 above.
- 5) Except as modified by these Terms and Conditions, SBS Bank's usual lending eligibility and criteria, fees, terms and conditions apply. Copies of SBS Bank's current Disclosure Statement along with our Lending Standard Contract Terms, a full list of our Credit Fees and Charges and General Terms and Conditions are available on request and free of charge from any SBS Bank Branch and at sbsbank.co.nz
- 6) To the extent permitted by law, SBS Bank, its employees and agents shall not be liable for any claims, damages, injuries, costs and expenses suffered, sustained or incurred (including but not limited to indirectly or consequentially) as a result of, arising out of, or any way connected with this Promotion (including receipt of, or use of the Highlanders prize pack).
- 7) All decisions of SBS Bank in relation to the Promotion are final and no correspondence will be entered into. SBS Bank reserves the right to vary these promotional terms and conditions at any time.

Prize Draw

- 8) The prize draw for the Highlanders prize packs will be randomly drawn at 11.00am on Thursday 1 April 2021. Each entrant in the Promotion will be entitled to a maximum of 1 prize draw entry.
- 9) There will be x3 Highlanders prize packs valued at \$500 to be won (the **Prize Packs**). Each Prize Pack

will include a Highlanders jersey signed by at least one member of the 2021 Highlanders squad along with promotional collateral.

- 10) The prize winners will be notified by telephone call once we have established that the prize winners have met the entry criteria for the Promotion. Where a prize winner is drawn, but that person:
 - i) does not contact SBS Bank within five working days; and/or
 - ii) has not met (or is unable to produce evidence that he/she has met) the entry criteria for the Promotion in paragraph 1 above,
we may, in our sole discretion, declare the entrant has forfeited their Prize Pack and redraw as soon as practicable.
- 11) SBS Bank will use the prize winner's personal information which it already holds on its database for this Promotion. In particular, SBS Bank will use this personal information to notify the prize winner, to organize the Prize Pack (which will include providing personal information to third party suppliers and organizers of the Prize Pack for this purpose) and to verify the prize winner's identity. The prize winners may be required to show their identification and evidence of their ordinary residential address (by producing an original utility bill or such other relevant document) in order to collect their Prize Pack.
- 12) The prize winners hereby consents to any photography or other publicity that SBS Bank, the Stonelake Foundation or the Highlanders' may reasonably request in conjunction with accepting and/or collecting the Highlanders Prize Pack.
