



## SBS Lite Get \$ Offer - Terms and Conditions

*Southland Building Society is a registered bank and operates under the brand "SBS Bank" (referred to as **SBS Bank**, **we** or **us**). SBS Bank together with its subsidiaries is the **SBS Group**.*

### **SBS Lite Get \$ Offer**

Simply become a new customer of SBS Bank by successfully opening a SBS Lite Account online and you will receive a \$100.00 credit (**Credit**) to your SBS Lite Account (the **Offer**). The Offer commences at 9:00am on 3 June 2021 and closes at 11.59pm on 14 June 2021 (the **Offer Period**). Participation in the Offer is deemed as acceptance of these terms and conditions.

You will also automatically go into a monthly prize draw to win a \$500 Visa Prezzy® Card if you make at least one withdrawal from, and one deposit to, your SBS Lite Account within the previous calendar month (the **Prize Draw**).
