

# Tour of Southland Photography Competition Terms and Conditions



- 1) The promoter of the Tour of Southland Photography Competition (the “**Competition**”), Southland Building Society, is a registered bank and operates under the brand “SBS Bank”. It is promoting the Competition in partnership with Cycling Southland Incorporated.
- 2) The Competition invites participants to submit original photographs which they have taken themselves, capturing the spirit of the Tour of Southland event – being held from Sunday 18 January 2026 to 24 January 2026.
- 3) Competition Dates
  - a) **Entries Open:** 11,00am Sunday, 18 January 2026
  - b) **Entries Close:** 5:00 PM, Tuesday, 26 January 2026
  - c) **Judging Period:** Wednesday, 27 January 2026 – Thursday, 28 January 2026
  - d) **Public Voting:** 9.00am Friday, 29 January 2026 – 5:00 PM, Thursday, 5 February 2026
- 4) To enter this Competition:
  - a) entrants must submit an original photograph of the Tour of Southland event that:
    - i) they have taken themselves;
    - ii) does not use AI or any computer-generated imagery;
    - iii) does not contain copyrighted material of third parties; and
  - b) entrants must submit their photograph by email to [marketing@sbsbank.co.nz](mailto:marketing@sbsbank.co.nz), and include their name and age in the body of the email, before the closing date as given in Clause 3.
- 5) A judging panel of representatives of SBS Bank and Cycling Southland will select the **top 10 entries** based on creativity, quality, and relevance to the Tour of Southland theme.

These top 10 entries will be posted on the SBS Bank Facebook Page for public voting.

Public votes will determine the final winner (the “**Competition Winner**”), and placeholders (the “**Competition Placeholders**”).
- 6) Prizes:
  - a) **First Prize:** A new mountain bike
  - b) **Second Prize:** \$200. Prezzie Card
  - c) **Third Prize:** \$100 Prezzie Card
- 7) The Competition Winner and the Competition Placeholders will be notified by email to the email address used to submit their entry.
- 8) The Competition Winner will receive a new mountain bike (the “**First Prize**”). The First Prize will be a model, make and design selected at the sole discretion of SBS Bank in the size required by the Competition Winner. The Competition Winner cannot select or swap the Prize, nor is the Prize redeemable as cash. Notice will be given to the Competition Winner when their First Prize is available to collect from the relevant local retailer.
- 9) The Competition Placeholders will win a Prezzie Card to the value of:

Second Prize - \$200  
Third Prize - \$100

These prizes are not transferable or redeemable for cash.
- 10) All decisions of SBS Bank and Cycling Southland regarding judging, voting, and prize allocation are final. No correspondence will be entered into.
- 11) This competition is not open to SBS Group staff or their immediate family.

- 12) The Competition Winner and the Competition Placeholders (and their parent/guardians, if applicable) consent to SBS Bank using their names and/or image(s) for all reasonable publicity associated with this Competition. The Competition Winner and the Competition Placeholders (and their parent/guardian if applicable) agree to make themselves reasonably available to SBS Bank for this purpose.
- 13) Entrants retain copyright of their photograph. However, entrants (and their parent/guardian, if applicable) agree to grant to SBS Bank and Cycling Southland (and any of its sponsors/partners) a worldwide, exclusive, and royalty free licence to reproduce, or otherwise use their photograph in connection with this Competition, and for any promotional purposes.
- 14) SBS Bank shall not be held liable for any loss or damage whatsoever which is suffered (including but not limited to direct or consequential loss) or for any personal injury suffered or sustained in connection with the receipt of, or use of the Prize, except for any liability which cannot be excluded by law. The Competition Winner will be responsible for supplying their own equipment for use of the First Prize, including an appropriate bicycle helmet.
